Missouri is in the process of adopting the 2020 edition of NFPA 58 the LP Gas Code, and the 2018 edition of NFPA 54 the National Fuel Gas Code. Come join us at the meeting as we present the major changes that will be adopted as our state standard. We will also discuss the difference between certification and qualification and how the two different designations apply to our daily job functions. We will apply these definitions by taking an in-depth look at requalifying cylinders as required by the Federal Department of Transportation per the Hazardous Materials Regulations, (49 CFR).

The 2020 Spring District Safety Meetings kick off on March 16 in Springfield and continue throughout the state ending March 26 in Eugene. In addition to the program items listed above, you will visit with your peers, enjoy a group meal and have a chance to win door prizes.
