

CETP Module 4.2: Vapor Distribution. What to expect: Students will take a number of quizzes and tests in order to assess their pace of learning. A multiple choice test will be administered at the end of the class.

This course addresses the different system tests & checks required when installing new piping, regulators and appliances or restoring service to an existing vapor distribution; validating the container, piping, and regulator; how and when to make the final connections; how to purge the system of air, appliance controls and safety devices, and how to adjust the burner.

MO-PERC (Missouri Propane Education & Research Council) funding underwrites the cost of student and test materials as well as a copy of 2018 NFPA 54, pencils, markers and other materials. Lunch and break refreshments are also provided. Other meals, lodging and travel are not included in the class fee.
